In no event shall DSC,WBR and RDC be liable for any damages or injury to permittee or any agent or employee of permittee, or to any person coming upon the premises in connection with the permittee's use and occupancy of the premises.

Permittee acknowledges that it shall reimburse DSC for any and all damage to DSC property, its agents and/or servants, as a result of the use and occupancy of the premises by permittee, its agents or servants, or by any person coming upon the premises in connection with permittee's use and occupancy of the premises.

Permittee agrees that the rights and obligations under the permit and this agreement shall injure to and be binding on its successors and assigns.
